Vendor Information & Rules

1. Availability - Areas are assigned first come, first serve subject to review and approval by event coordinator--full payment and acknowledgment of event rules is required for reservation.
2. Size/Location – **Outside:** Vendor are responsible for table, chairs, displays, canopies (with approval), etc. Registration fee covers space only. Limited electrical access is available and may be requested when registering. **Inside:** one 6' table and two chairs may be provided. (Limited availability.) Electrical access is available.
3. Set-Up - Venue opens at 7:30 am on day of event; set-up must be complete by 9:30 am and all vehicles removed from event area. Vendors not set up by 9:30 am may forfeit participation. If you are bringing your own table, the church will be open for you to bring it on Thursday prior to the event from 9am-3pm.
4. Tear-Down - Booths must remain open for the duration of the event. Tear-down begins at 3 pm. Early departure may result in disqualification for future events. No vehicles on grounds until 3 pm.
5. Inclement Weather - There is no rain date and no refund of booth fees due to weather. Event coordinator will determine if weather poses a hazard and alert vendors as soon as is feasible.
6. Parking - Vendors must follow all local parking regulations. There are designated parking spaces for vendors. The event coordinator will tell you where to park on the day of the event. Please limit one vehicle per vendor to help free up parking for customers.
7. Property/Safety - Vendors must take all due care to protect St. Mark's landscaping, property and event attendees. All canopies must be properly weighted, if approved. **Animals are not permitted.**
8. Merchandise Limits - Food or drink for on-site consumption are not allowed, unless approved by coordinator. Items that are offensive or inconsistent with the decorum of St. Mark's are prohibited.
9. Sales Activity - All sales must occur within defined booth space. Vendor will comply with all applicable community laws and regulations and the rules of St. Mark's as stated in this application.
10. Emergencies - Any issues must be brought to the attention of event coordinators.

Participation Waiver

The undersigned vendor, on behalf of itself and its officers, directors, agents and employees, agrees to abide by all Fall Craft Show and Vendor Rules of St. Mark's Episcopal Church. The undersigned vendor additionally waives all rights without limitation and releases St. Mark's Episcopal Church, and its officers, directors, agents and employees, the protestant Episcopal Diocese of Texas and the Bishop of the Diocese of Texas, from any and all liability whatsoever for any injury or death to person or loss or damage to property, resulting from any cause whatever other than gross negligence or willful misconduct of St. Mark's Episcopal Church, its officers and employees.
